- Your plan on driver training when you eventually hire more employees.
- How often you plan to conduct background and driver's license checks on your future employees. You are required to conduct at least an annual driver's license check and a biennial background check.

I have an account on the SentryLink website that will allow me to conduct nationwide background checks as well as MVR checks on future employees/drivers. Background checks will be run on new hires and every 2 years after while with the company. MVR checks will be run annually on future drivers as well as acquiring a DOT Medical Examiners Card. Potential new drivers will be carefully instructed on the specific safety and operational rules of a CMV. New drivers will be accompanied by an experienced driver in the truck cab for the first month to ensure safe operation.

3.) Please provide a more detailed maintenance plan for your vehicles and a plan to ensure proper maintenance if you are planning to use rental trucks from Budget in your operations.

Vehicles will be monitored and maintained on a regular basis. A routine walk around inspection of the vehicle will be conducted by the driver before leaving and after returning each day the vehicle is used to ensure no safety hazards and safe operating (this includes any rental trucks utilized for company use.). Vehicles will be routinely serviced with a local certified mechanic on a quarterly basis to ensure mechanically safe and make replacements/repairs as needed.

4.) Please provide additional information regarding your 4th degree felony conviction from 2013. Are you on probation for this conviction? What is your status on this situation?

Arrest was in 2013. In 2014, I was sentenced to 2 years of probation and to serve community service hours. I completed all requirements and was taken off probation early approximately at the end of 2015. 
