

Enclosed are updates for 358th Revised Page 2, 128th Revised Page 2-B, and 1st Revised Page 70-C for Miracle Movers of Pittsburgh, LLC (PA PUC # A-8922412) in Pittsburgh PA. This filing is for an INCREASE in their hourly rates for the Vehicle (all columns) and Driver, Additional Men, and Supervisors in Column 3 and a REDUCTION in their hourly rates for Driver, Addition Men, and Supervisors in Columns 2 and 4. There is also a REDUCTION in the minimum hours for moves performed on Sundays & Holidays (any hour) under Note 4. The minimum hours for Weekdays (8:00AM to 5:00PM), Saturdays (any hour), and Weekdays (5:01PM to 7:59AM) remain the same. The effective date for these exceptions in Tariff 54 is March 18th, 2021. NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

▲ NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 4 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (5:01PM to 7:59AM): 4 hours at rates named in Columns 1 and 4. Weekdays (8:00AM to 5:00PM): 4 hours at rates named in Columns 1 and 3.

NOTE 5 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier.

NOTE 6 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps or MapQuest.

0-20 miles	1 hour
21-40 miles	1 1/2 hours
41-60 miles	2 hours
For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 20 miles.
