

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Monday thru Friday: Four (4) hours at rates named in Columns 1 and 3 or 4. A five (5) hours minimum will apply from May 1st to October 1st. Saturdays, Sundays and Holidays: Eight (8) hours at rates named in Columns 1 and 2 or 4.
