

▲ In lieu of the applicable rates provided for in Tariff Freight PA. P.U.C. No. 51-W, the following rates shall apply:

NOTE 1 - MINIMUM WEIGHT CHARGE (Rule 33) - The minimum weight for all shipments will be 2,500 pounds.

NOTE 2 - LABOR RATE (Item 120) - Labor Rate will be \$42.00 per man per hour (REGULAR RATES) and \$63.00 per man per hour (OVERTIME RATES) for all counties in Pennsylvania, regardless of in which county labor is performed.

NOTE 3 - ADDITIONAL TRANSPORTATION CHARGE (Item 160) - An additional fee of \$5.50 per 100 pounds will apply at both origin and destination for all counties in Pennsylvania, regardless of in which county shipment originates or is destined.

NOTE 4 - STORAGE-IN-TRANSIT AND WAREHOUSE HANDLING CHARGES (Item 200) - Rates shown in Item 101 for Chester County will apply for all counties in Pennsylvania, regardless of in which county storage services are performed.

NOTE 5 - EXTRA PICKUP AND/OR DELIVERY (Item 230) - Rates shown under Schedule E will apply for all counties in Pennsylvania, regardless of in which county Extra Pickup or Delivery occurs.
