Enclosed for filing with the Pennsylvania Public Utility Commission ("PUC" or "Commission") pursuant to Chapter 21 of the Public Utility Code are the original and four (4) copies of the updated Schedule B-1 of Contract for Services between Wellsboro Electric Company ("Wellsboro" or "Company") and its parent corporation, C&T Enterprises, Inc. ("C&T") (individually, each a "Party" and collectively, the "Parties"). This letter describes the changes and updates reflected in this filing.
