RULES & REGULATIONS

1. **MILEAGE**

Mileage will be computed from the meter of the vehicle being used and will be calculated from the passenger's pick-up to the passenger's drop-off.

2. **PAYMENT OF OUT-OF-POCKET EXPENSES**

The rates and charges in this tariff cover transportation only. All tolls, parking fees and other out-of-pocket expenses shall be the responsibility of the passenger and will be added onto carrier's charges.

3. **HOLIDAY SURCHARGES**

Surcharge rates are charged for Holiday as stated below.

Each additional 1/7 th mile or fraction thereof	\$ 0.40 (A)
Waiting time: Each minute or fraction thereof:	\$ 0.50

All trips between the hours of 10:00 pm and 6:00 am:

First 1/7 th mile or fraction thereof (flag drop)	\$5.20
Each additional 1/7 th mile or fraction thereof	\$0.45
Waiting time: Each minute or fraction thereof	\$0.75

An Additional charge of \$ 5.00 per trip will be added on the following holidays: (A)

New Year's Eve after 5:00 pm	Labor Day
New Year's Day	Thanksgiving
Easter	Christmas Eve after 5:00 p.m.
Memorial Day	Christmas Day
July 4 th	

A minimum charge of \$10.00 will be imposed upon all credit card charges. (C)

A 4% credit card surcharge will be imposed upon all credit card charges in excess of \$10.00. Customers are required to present picture ID that match the credit/debit card used for payments. (C)
