RULES AND REGULATIONS

This tariff contains the rules and regulations and the schedule of rates for Easton Coach Company LLC's Group and Party 15 or Less service.

Operating Authority – Group and Party 15 or Less Service

1. Persons in group and party service, from that portion of Monroe County south of U. S. Highway Route 209 and west of Pennsylvania Highway Route 33, east of Pennsylvania Highway Route 33, south of a line due east and west through Bossardsville to the Northampton County Line, to points in Pennsylvania, and return; and
2. Persons in group and party service from that portion of Northampton County east of Pennsylvania Highway Route 33 and north of U. S. Highway Route 22, including the city of Easton and the Laneco Shopping Center in Palmer Township, Northampton County, at the intersection of William Penn Highway and Stone's Crossing Road, to points in Pennsylvania located within an airline distance of seventy-five (75) statute miles of the limits of the city of Easton, Northampton County, plus Derry Township, Dauphin County, and return.

RULES AND REGULATIONS

1. If calculated by mileage, rates shall be calculated by the odometer of the vehicle used and will be calculated from the customer's pick-up to the customer's drop-off.
2. If calculated by time, hourly rates shall from calculated from garage to garage.
3. Advance reservations must be made no later than the previous calendar day of when the service is to be rendered.
4. Additional expenses necessitated by or incurred at the request of the party making the reservation, including, but not limited to, highway tolls and parking, etc., shall be added to the charge of the trip.
5. Expenses for driver's lodging and meals while on trips out of town that are in excess of ten (10) hours will be added to the basic charge.

SCHEDULE OF RATES

Hourly rates per hour - two hour minimum - per vehicle

After 6:00 p.m. and on Saturdays, Sundays and Holidays, the above hourly rates are subject to an additional surcharge of 20%. The Holidays subject to this surcharge are the observed United States legal Holidays identified below:

- New Years Day (January 1)
- Memorial Day
- Independence Day (July 4)
- Labor Day
- Thanksgiving Day
- Christmas Day (December 25)

Trips that exceed 10 miles will have an additional charge of \$3.50/mile.

If an escort or attendant is required due to the health, disability or age of the primary passenger, a charge of \$1.00 will be made for that person in lieu of all other charges. A letter signed by a physician, attesting to the need for an escort, will be required and must be filed with the carrier.

Waiting time charges shall apply after the first five minutes of waiting time at the rate of \$24.00 for each ½ hour of wait time.
