

Attached are updates for 367th Revised Page 2, 7th Revised Page 20-F, and 1st Revised Page 20-F-1 for Armstrong Relocation Company, Pennsylvania, LLC, t/a Jack Treier Moving & Storage (PA PUC #A-8917264) in Mount Joy PA. This filing is for an INCREASE in local hourly rates for Peak Season Vehicle & Driver rates. All other hourly rates remain the same. There is also a CHANGE in the dates for Peak Season and Non-Peak Season, as well as, CHANGES in Tristate 51-W rates for minimum weight charge on shipments transported 100 miles or more, packing & unpacking rates, labor rate, additional transportation charge, storage-in-transit rates, extra pickup or delivery charge, overtime loading & unloading charge, and elevator/stair carry/excessive distance charges. The Issue Date is March 23rd, 2021 with an Effective Date for these changes in the Exceptions Tariff, Tristate 54, on April 22nd, 2021. NOTE 2 - WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE

Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete the move plus applicable travel charge.

NOTE 3 - When a holiday falls on a Saturday, rates named in Columns 1 and 2 shall be applicable.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps or MapQuest.

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.

CANCELLATION FEE

Armstrong Relocation Company, Pennsylvania, LLC t/a Jack Treier Moving & Storage reserves the right to charge cancellation fees in the following amounts:

On jobs cancelling within twenty-four (24) hours of scheduled start time, shipper will be charged two (2) hours for labor and equipment at the estimated hourly rates.

On jobs cancelling less than forty-eight (48) but not more than twenty-four (24) hours of scheduled start time, shipper will be charged one (1) hour for labor and equipment at the estimated hourly rates.

BOOKING COMMISSIONS

Armstrong Relocation Company, Pennsylvania, LLC t/a Jack Treier Moving & Storage requests the permission to implement a 20% booking commission on the line haul portion of all Intrastate PA shipments moving in excess of forty (40) miles that are booked for the privilege of a third party relocation company and/or Intrastate PA move requests of over forty (40) miles made by a foreign agent. This additional booking commission will not be levied upon any shipment sold by and booked by the Armstrong Relocation Company, Pennsylvania, LLC t/a Jack Treier Moving & Storage sales force.

▲ In lieu of the applicable rates provided for in Tariff Freight PA. P.U.C. No. 51-W, the following rates shall apply:

NOTE 1 - MINIMUM WEIGHT CHARGE (Rule 33) - The minimum weight for shipments transported 100 miles or more will be 4,500 pounds.

NOTE 2 - PACKING & UNPACKING RATES (Item 110) - Packing & unpacking charges will be based on Schedule C rates for all counties in Pennsylvania.

NOTE 3 - LABOR RATE (Item 120) - Labor Rates shown in Item 101 for Lancaster County will apply for all counties in Pennsylvania.

NOTE 4 - ADDITIONAL TRANSPORTATION CHARGE (Item 160) - Rates shown under Schedule 2 will apply for all counties in Pennsylvania.

NOTE 5 - STORAGE-IN-TRANSIT AND WAREHOUSE HANDLING CHARGES (Item 200 and Section 3) - Rates shown in Item 101 for Lancaster County will apply for all counties in Pennsylvania when storage-in-transit is at carrier's facility in Mount Joy PA.

NOTE 6 - EXTRA PICKUP AND/OR DELIVERY (Item 230) - Rates shown under Schedule D will apply for all counties in Pennsylvania.

NOTE 7 - OVERTIME LOADING/UNLOADING (Item 240) - Rates shown in Item 101 for Lancaster County will apply for all counties in Pennsylvania.

NOTE 8 - ELEVATOR, STAIR CARRY, EXCESSIVE DISTANCE (Item 260) - Rates shown under Schedule D will apply for all counties in Pennsylvania.
