Dear Secretary Chiavetta:

In accordance with 52 Pa. Code § 54.34 and 52 Pa. Code § 62.105, the NRG retail affiliates, including Energy Plus Holdings LLC, Green Mountain Energy Company, Independence Energy Group LLC, Reliant Energy Northeast LLC, XOOM Energy Pennsylvania, LLC, Stream Energy Pennsylvania, LLC, Direct Energy Services, LLC, Direct Energy Business, LLC, Direct Energy Business Marketing, LLC, Gateway Energy Services Corporation, and Bounce Energy, Inc. provide the following updates to their licenses:1

1. Effective January 5, 2021, NRG Energy, Inc. ("NRG") acquired 100% of the membership interest in Centrica US Holdings Inc., the parent company of Direct Energy Services, LLC, Direct Energy Business, LLC, Direct Energy Business Marketing, LLC, Gateway Energy Services Corporation, and Bounce - Energy, Inc. ("Direct Energy" or "the Companies"). Direct Energy will retain its licenses and all customers currently served by Direct Energy will continue to be served by the Companies. The Companies will become NRG

subsidiaries, similar to and affiliated with the other NRG retail affiliates noted above.

- .2. The Companies' names, FEINs, and DUNS numbers shall all remain the same. The Companies shall maintain their principal business addresses, customer service/complaint contacts, attorney, and registered agent until such time that NRG notifies the Commission of any changes.
