FAUSTO RODRIQUEZ, OWNER OF RODRIGUEZ TRANSPORTATION, HEREBY REQUESTS A RECONSIDERATION OF THE RESPONDENTS FAILURE TO FILE AND ANSWER TO THE COMPLAINT AND FAILURE TO HAVE HIS INSURER FILE EVIDENCE OF BODILY INJURY AND PROPERTY DAMAGE INSURANCE WITH THE COMMISSION.

- 1) THE RESPONDENT, FAUSTO RODRIGUEZ OF RODRIGUEZ TRANSPORTATION, HEREBY STATES THAT HE RECEIVED NOTIFICATION OF COMPLAINT FROM THE PENNSYLVANIA PUBLIC UTILITY COMMISSION, ON OR ABOUT NOVEMBER 24, 2020 FOR NON-COMPLIANCE OF REQUIREMENTS.
- 2) UPON REVIEW OF THE NOTICE, THE RESPONDENT CONTACTED HIS INSURANCE AGENT (INSURANCE CARRIER) AND WAS INFORMED THAT THE PROPER FILING HAD BEEN COMPLETED. IT WAS THE UNDERSTANDING OF THE RESPONDENT THAT ALL REQUIRED DOCUMENTS AND FILINGS WERE SUBMITTED TO THE COMMISSION.
- 3) THE RESPONDENT HEREBY STATES THAT HE RECEIVED A CANCELLATION NOTICE ON OR ABOUT MARCH 13, 2021, FOR FAILURE TO MAINTAIN INSURANCE COVERAGE. MR. RODRIGUEZ AGAIN CONTACTED HIS INSURANCE AGENT (INSURANCE CARRIER) AND WAS INFORMED THAT HIS COVERAGE WAS IN EFFECT. UPON FURTHER REVIEW, MR RODRIGUEZ REQUESTED VERIFICATION OF THE INSURANCE FILING AND WAS TOLD THE FILING WAS SUBMITTED BY HIS CARRIED IN OCTOBER 2020, AND HIS AGENT HAD RECEIVED A NOTICE OF FILING (SEE ATTACHED FILING SUMMARY) IN DECEMBER 2020. AS PER MR. RODRIGUEZ INSURER, THERE HAS BEEN NO LAPSE OF INSURANCE COVERAGE AND ALL FILINGS WERE SUBMITTED AS PER HIS REQUEST.
- 4) RESPONDENT, MR. RODRIGEUEZ OF RODRIGUEZ TRANSPORTATION, HAS MADE EVERY ATTEMPT TO ANSWER AND TO BE IN COMPLIANCE WITH THE PENNSYLVANIA
