- 1.) HCA analysis was rerun throughout 2020 affecting the HCA/non-HCA mileage in the following counties: Beaver, Berks, Blair, Carbon, Dauphin, Lancaster, and Lebanon.
- 2.) 0.1 mi was moved from Dauphin county to Cumberland county due to a resolved issue with county border location.
- 3.) 0.7 mi was removed from Delaware county reflecting a line Buckeye does not own or operate.
- 4.) 0.7 mi was added to Delaware county location of county border did not previously include this mileage.
- 5.) All mileage in Lycoming county (1.4 mi) was removed after a recent jurisdictional determination. New determination classifies mileage as non-jurisdictional.
- 6.) 2.0 mi was removed from Philadelphia county reflecting a line Buckeye does not own or operate.
