In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less.

Full Value Protection Coverage, if requested by customer, is \$6.00 per \$1,000.00 of declared value of the customer's belongings with a minimum declared value based on \$5.00 times the weight of the shipment or \$10,000.00, whichever is greater (customer pays a minimum premium of \$60.00) and a \$150.00 deductible applies no matter what level of coverage the customer has selected.
