Re: my letter to you, December 7, 2020
I received a copy of her exceptions on December 15, 2020.
i.e. from Emily Farah, Attorney for D.C. When her
secretary called me to provide your phone number
to me because your recent 2 letters had no phone
numbers posted, through some discussion and my
questioning she said I could make exceptions to Miss
Farah's exceptions.

I haven't been home during this winter
season, where my records are filed, so I'll just
note what I remember.

In recalling the meeting with Judge
Hoyer, on 2-3 occasions he denied me to make
any contacts from the meeting with Judge Munderdale.
Here, attorney Farah in her letter of exceptions cites
actions in her November or December 2020 Pt. the 2017
meeting - items which should be denied by Judge
Hoyer, (p. 2-3, TP 1.

Part II, p. 3, is jumbled to make heads or tails of what is not clearly understood.

Part III, TP 3 she cites "Prior Complaint" and was allowed by Judge Hoyer, sentence 2 1st TP, p. 4; but he denied my comments in 2nd hearing. In same paragraph 2, p. 4 " --- on the merits" --- not defined! And item 4 talks to 1st complaint which Judge Hoyer did not hear or make comment to.

Unnumbered, TP 5 she makes the judgment, presumably, that --- "it is not in the public's or the commission's best interest to entertain or afford the Complainant's claims ---" whether it's right or wrong, or justice or injustice.

III B, p. 4. (bold print) --- while he is not physically present is inaccurate as a matter of law." and some ending of sentence # 1.

P. 4, BTP 2 another opinionated judgment. Because the property is listed in owner's name does not indicate his accountability when he is not using the service. That power is in the line from the house to the telephone pole - ergo: it's not in use if no equipment is used via of the power.

I recall that in our first hearing I had enclosed sent that on the back of the billing page I had marked the threats that were made to shut off power to my house if I had not paid my bill, & that my first exhibit "A", p. 3B3, dated 9-21-19 was the first exhibit. (for reference of what successive bills showed.)

At 91, my budget is tightly managed. \$168⁰⁰ is my social security payment, per month.

1956-57, 1957-58, 1958-'59 = 3 years as a teacher. The Government opened social security for teachers, beginning school year 1958-59.

BUT: It required me to pay back social security taxes for the '56 and '57 school years ^{to} be able to join SS in 1958, \$2000, \$2200, \$2400 per year was my salary and for 2 years they wanted me to pay 2 years deductions to be eligible to join SS in 1958 & had to pay about \$280⁰⁰ as SS taxes for 2 years to be eligible in 1958 to become a member. For me and my mother, I could not afford the \$280⁰⁰ because we were still under the depression era --- when my family (mother and I) lived. This opening in 1958 and requiring pay back for 2 years outside of the law was "Ex post FACTO." Outside the law! Ergo: I taught until retirement in 1990 without social security benefits until I worked 5 years to make

40 quarters of eligibility to receive any S. S.
Thus, I became eligible for \$260 S.S. with
tax deductions of (c.) \$1000. My \$160 pays for
food, car expenses, home taxes and room
& board at my daughter's. My pension
supplements these expenses for 30 years
of retirement thus far.

I am a widower for 30 years,
since 1990.

By the way, I'm still waiting
for a copy of the record of the minutes
made by the court recorder.

Since I sent my first exception to
you, Mrs. Chivetta, the attorney received
one also. Please let me know who else received
a copy of my exceptions.
