INTERIM ORDER #1

The Complaint in this proceeding, for which a hearing is scheduled on May 12, 1998, indicates that the Complainant might be a corporation. Under the Commission's regulations and decisions, corporations must be represented by an attorney-at-law in adversary proceedings before the Commission. See 52 Pa. Code §1.22 and Lestat Corp. v. PP&L, C-946284 (entered August 30, 1995).

Also, it is a misdemeanor of the third degree to practice law without being an attorney-at-law. 42 Pa. C.S. §2524. The prohibition against the practice of law by a lay person applies to proceedings before administrative agencies, including this Commission. Walacavage v. Excell 2000, Inc., 480 A.2d 281 (Pa. Superior Ct. 1984).

The Complaint in this proceeding does not indicate that Tiffany Associates is represented by an attorney.


Therefore, in accordance with the foregoing,


