

Attached are updates for 373rd Revised Page 2, 207th Revised Page 2-A, 4th Revised Page 42-B, and 5th Revised Page 42-C for Glamour Moving Company, Inc. (PA PUC #A-00112271) in Westminster MD. This filing is for an INCREASE in local hourly rates on Sundays & Holidays (any hour), and vehicle & driver only rates on Weekdays (any hour) and Saturdays (any hour).
