Dear Secretary Chiavetta:

Pursuant to 52 Pa. Code § 54.40, enclosed for filing with the Public Utility Commission ("Commission") is Palmco Power PA, LLC d/b/a Indra Energy's ("Indra") Financial Security Reduction Petition ("Petition"). Both redacted and confidential versions of the Petition are attached herein.

In accordance with the Final Order entered July 24, 2014, at Docket No. M-2013-2393141, Indra respectfully requests a reduction of its financial security amount from 10% to 5% of its most recent 12 months of gross receipts. Enclosed is a certified check for \$350 made payable to the "Commonwealth of Pennsylvania", as required. Indra further certifies that its Petition (non-confidential documents only) has been served on the five statutory agencies and all electric distribution companies in which Indra is licensed to operate in the state of Pennsylvania.

Enclosed as **Exhibit A** is a signed Certificate of Service evidencing proof of service to the interested parties listed therein. Enclosed as **Exhibit B** is Indra's most recent 12 months of gross receipts for electricity supply service in Pennsylvania.
