On March 23, 2021, PAWC served copies of the Application on the parties referenced in the Secretarial Letter. A Certificate of Service evidencing this is attached to this letter.

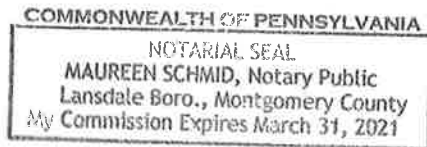


