Attached are updates for 376th Page 2, 133rd Revised Page 2-B, 2nd Revised Page 85-G, and 1st Revised Page 85-G-1 for Reliable Movers, LLC, t/a Reliable Movers (PA PUC #A-8922701) in Whitehall PA. This filing is an INCREASE for all Non-Peak Season rates and an INCREASE for selected Peak Season Rates (Vehicle – less than 24', Driver/Supervisor, and Additional Men/Helper Monday-Friday (7:00AM to 6:00PM), Saturday (any hour), and Weekdays (7:01PM to 6:59AM). It is REDUCTION for Peak Season vehicle – 24' or 26' (any day/any hour) and Additional Men/Helper on Sundays & Holidays (any hour). The Peak Season rate for Vehicle – less than 24' and Driver/Supervisor remain the same as previously filed. They also REMOVED their exceptions for container rates. When containers are now supplied by the carrier, they will use the container rates in tariffs, Tristate 50-T and Tristate 51-W. The Issue Date is April 12th, 2021, and the Effective Date for these exceptions in Tariff 54 is May 12th, 2021. NOTE 5 - A deposit of \$250.00 is required on all moves. Deposit will be refunded if move is cancelled or rescheduled 10 days prior to the move date. If notice of cancellation is less than 10 days prior to the move date, deposit is non-refundable.

NOTE 6 - If a piano or safe are included in the shipment, a handling fee of \$100.00 per item will apply in addition to hourly charges. A special handling fee of \$100.00 will apply for Grandfather Clocks, Arcade and Pinball machines, and Peloton or similar exercise equipment in addition to hourly charges. Handling fee in addition to hourly charges when pool table is included in shipment is \$300.00.

NOTE 7 - If shipment needs to be held overnight, for the convenience of the shipper, a charge of \$200.00 per vehicle per night will apply for vehicle(s) less than 24 feet in length - for vehicle(s) 24 feet or 26 feet in length, charge is \$350.00 per vehicle per night.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.

NOTE 1 - In lieu of applicable rates provided for in Tariffs Pa. P.U.C. No. 50 (Item 301) and Pa. P.U.C. No. 51 (Item 110) for packing & unpacking labor, charges for packing & unpacking labor will be based on the hourly rates (Peak Season & Non-Peak Season) on Page 85-G.
