Dear Secretary Chiavetta:

Pursuant to the Pennsylvania Public Utility Commission's ("Commission's") Secretarial Letter dated March 1, 2021 in the above-referenced docket, PECO Energy Company ("PECO") was directed to publish the Commission's notice regarding the sale of certain street lighting facilities (the "Notice") in the Bucks County Courier Times on or before March 29, 2021.

Accordingly, PECO made arrangements for the Notice to be published by the Bucks County Courier Times. Upon discovery that the paper failed to publish the legal notice as instructed, PECO contacted the Commission for guidance and was advised by Secretary Chiavetta to re-schedule the Notice for publishing with the Bucks County Courier Times and revise the original Notice (the "Revised Notice") to reflect an updated 15-day protest period (until April 28, 2021) as required by 52 Pa. Code 5.14(d).

The Revised Notice was published by the Bucks County Courier Times on April 13, 2021. Enclosed is proof of that publication.

Due to the ongoing COVID-19 pandemic, PECO's office personnel are working remotely. Accordingly, PECO will not have its usual access to photocopying and U.S. mail, among other services. PECO requests that all communications with PECO be transmitted by email.
