I placed a call to your office on Saturday 11-6-2020 to request a couple more days to get my information to you. Thus far I have some of my receipts. I have a enormous amount of files.

I don't have the receipts from my being in the Protection Against Abuse program. Was not allowed to stay in that program because immigration would not disclose where my x-husbands residence was located to my attorney to serve him stay away papers. My x-husband is aware of my location which he has frequented ,in an attempt break in my home.

I also could not locate the receipts of the \$1,200.00 I paid to have my service re-connect this year last winter, when I was out power for three weeks and had to go to the hospital daily to get oxygen. My Pulmonary doctor had submitted a letter and medical request asking PECO to work with me. PECO returned it stating it was not submitted properly. I'm not eligible for CAP. The best agreement that could be worked out with me was stated \$588.00 per month. I live alone and sole supporter of myself. I do not receive all of my income. Still fighting for my Pension from the City of Phila.,25 years of service and my benefits from the Air Force, 6 years of service. Life has been Traumatic, cant give up I have to endure. I was awarded thousands of dollars as a result of the Mortgage Fraud case I won. The owner of the companies didn't even show up in court but was given leniency and was to compensate me but it was never paid. Judge, I *apologize*
