Respondent, Monona, LLC, has paid the amount sought by the Pennsylvania Public Utility Commission's ("PUC") Bureau of Investigation and Enforcement ("I&E") in order to resolve the above-docketed complaint. On March 29, 2021, the Commission accepted payment in the amount of \$3,115.50, which was the amount of the civil penalty (\$2,512.50) and interest (\$603) in the above-referenced complaint under Docket Number C-2020-3023168. On April 15, 2021, the Commission accepted payment in the amount of \$1,000, which was the amount of the agreed upon administrative penalty for Docket Number C-2020-3023168. 
