On February 11, 2021, TriEagle Energy, LP ("TriEagle Energy") filed its 2021 Annual Compliance Filing to maintain its bonding level of 5% of its most recent 4 quarters of revenue subject to the minimum of \$250,000, per the Commission's Orders entered July 24, 2014, at Docket No. M-2013-2393141 and September 20, 2018, at Docket No. P-2017-2608078.

On April 8, 2021, the Commission notified TriEagle Energy (via email) that its Annual Compliance Filing was incomplete and requested a response to following:

1. Reference Annual Compliance Filing - If Applicant has prepaid its gross receipt taxes to the Pennsylvania Department of Revenue for 2021, please provide a REV-423 Specialty Tax Estimated Payment Form as proof of the prepaid gross receipt taxes. If not, please indicate that the Applicant has not prepaid its 2021 gross receipt taxes.

Please find enclosed TriEagle Energy's response to the Commission's request. TriEagle Energy, LP respectfully requests that the Commission grant Confidential Treatment to the attached documents. It is TriEagle Energy's position that the information contained in these documents is of a proprietary and/or confidential nature. 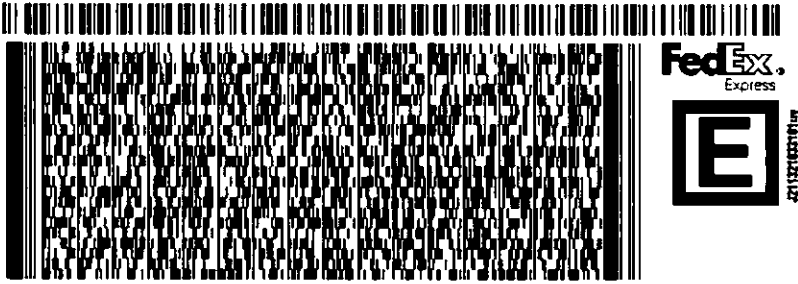

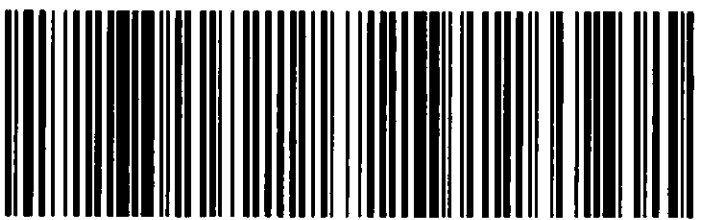
