

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less.

Subject to Notes AA and 1 to 8 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3, and 4.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Saturdays and Holidays: three (3) hours at rates named in Column 2 plus applicable travel charge.

NOTE 5 - Minimum Transportation Charge: Sundays: three (3) hours at rates named in Note 8 plus applicable travel charge.

NOTE 6 - When services commences on a weekday, at the request of the shipper, after 5:00PM or before 6:00AM, rates shall be as shown in Column 4 plus applicable travel charge.

NOTE 7 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between shipper and carrier.

◆ NOTE 8 - SPECIAL - time and a half rates will apply when work is performed on Sundays:

Vehicle/Driver - \$105.00 per hour - Additional Men/Laborer - \$60.00 per hour - Supervisor - \$105.00 per hour

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps or MapQuest.

0-15 miles	1/2 hour
16-30 miles	1 hour
31-45 miles	1 1/2 hours
46-60 miles	2 hours
For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
