

NOTE 4 - WAIVER OF MINIMUM CHARGES - CARRIER CONVENIENCE: carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum numbers of hours filed and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time to complete move plus applicable travel charge.

NOTE AA - A travel charge will apply on all local residential moves in an amount to be determined as follows:

If mileage from carrier's facility to point of origin and from final point of destination to carrier's facility exceeds 40 miles, the additional travel time charge will be based on 1/2 hour per each additional 15 air miles.
