Dear Secretary Chiavetta:

The purpose of this letter is to notify you that, pursuant to 52 Pa. Code § 5.61(d), this matter involves a rate proceeding and the Pittsburgh Water and Sewer Authority ("PWSA") is electing not to file a formal answer to the complaints filed by the Office of Small Business Advocate ("OSBA") and the Office of Consumer Advocate ("OCA"), nor to any subsequently filed complaints.

On April 13, 2021, PWSA filed support for a requested increase in base rates at Docket Numbers R-2021-3024773 (water), R-2021-3024774 (wastewater); R-2021-3024779 (stormwater). Simultaneously, PWSA filed: (1) A Petition to Consolidate the two utility rate cases and to utilize combined water and wastewater revenues; and, (2) A Petition for Waiver of Statutory Definition of Fully Projected Future Test Year.

The OCA filed complaints on April 23, 2021 and they are docketed at C-2021-3025473 (water); C-2021-3025471 (wastewater); and, C-2021-3025474 (stormwater). The OSBA filed complaints on April 26, 2021 and they are docketed at C-2021-3025516 (water); C-2021-3025517 (wastewater); and, C-2021-3025521 (stormwater). Pursuant to 52 Pa. Code § 5.61(d), PWSA has elected to not answer any of the complaints since they are complaints in a rate proceeding. Please contact me with any questions.
