

Attached are updates for 386th Revised Page 2, 137th Revised Page 2-B, 6th Revised Page 68-A, and 3rd Revised Page 68-B for Metro Moving and Storage, Inc. (PA PUC #A-00113363) in Duquesne PA. This filing is an INCREASE in the local hourly rates for major holidays and Weekdays, Saturdays, and Sundays (6:01AM to 6:00PM), a REDUCTION in hourly rates for Weekdays, Saturdays, and Sundays (6:01PM to 6:00AM), a CHANGE in the verbiage for Travel Time charges, an INCREASE for Grandfather Clock box, the ADDITION of charges for Mattress Bags and TV Cartons, and an INCREASE in the packing labor hourly rate. Also made a change at the top of the page for coverage area as Metro Moving and Storage, Inc., was grandfathered statewide operating authority in May 2015. The Issue Date is April 30th, 2021, and the Effective Date for these exceptions in Tariff 54 is June 1st, 2021.
