**(C) OPERATING AUTHORITY**

To transport, as a common carrier, persons in limousine service,  
Between points in Pennsylvania. Excluding Allegheny County.

## **RULES AND REGULATIONS**

### **(C) ADVANCED RESERVATIONS**

Reservations must be made 24 hours prior to service being rendered.

### **(C) AIRPORT WAITING TIME**

Waiting time at airports will be subject to an hourly rate or fraction thereof after a free allowance of (1) one hour. This hourly rate will be based on the type of vehicle the client has scheduled.

### **(C) DEPOSITS**

All reservations require a deposit of not more than 20% of the quoted charter price. Deposits are subject to forfeiture of not more than 50% of the deposit if the charter is cancelled by the customer more than 15 but less than 30 days prior to the date transportation was to depart, and forfeiture of not more than the total amount of the deposit if the cancellation occurs within 15 days prior to the date the transportation was to depart.

### **(C) HOURLY RATES**

Hourly rates start from the time the carrier leaves the garage until the carrier returns to the garage.

### **(C) DRIVER GRATUITY**

A 17% gratuity may be assessed in addition to all other published rates and charges.

### **(C) CORPORATE/DISCOUNT RATES**

A 15% discount off our base fare will be given to any user of our service that reserves 6 or more transfers within a 30 day period.

### **(C) PAYMENT OF OUT OF POCKET EXPENCES**

All tolls, parking fees & other out of pocket expenses shall be the customers responsibility and will be added to the carriers charges.

### **(C) PROMOTIONAL FARES**

Upon presentation of advertising coupons or special promotional fares, the carrier will offer rates at a specified discount from the published Tariff rates on dates authorized by the coupon or special promotional offer. The advertised coupon or promotional offers will be filed with the Public Utility Commission prior to publication or broadcast. Coupons will be published and promotional offers will be broadcasted in one or all of the following manners: local newspapers, fliers and other types of print media. All forms of radio, television and internet.
