On April 13, 2021, PAWC served copies of the Application on the parties referenced in the Secretarial Letter. A Certificate of Service evidencing this is attached to this letter.

In Compliance with the Secretarial Letter and in compliance with the Final Supplemental Implementation Order entered at Docket No. M-2016-2543193, PAWC advised the Commission on March 5, 2021, that it was beginning to provide individualized notice of the proposed acquisition to all potentially affected PAWC water and wastewater division customers. 
