ADDENDUM AGREEMENT

ADDENDUM ATTACHED TO AND MADE PART OF AGREEMENT DATED THE 11TH DAY OF APRIL, 1974, BY AND BETWEEN MIDDLETOWN TOWNSHIP, BUCKS COUNTY, MUNICIPAL AUTHORITY, MIDDLETOWN TOWNSHIP BOARD OF SUPERVISORS, MUNICIPAL SEWER AUTHORITY OF THE TOWNSHIP OF LOWER MAKEFIELD, AND LOWER MAKEFIELD TOWNSHIP BOARD OF SUPERVISORS

WHEREAS, the above parties have entered into an Agreement dated the 11th day of April, 1974, under the terms of which Middletown Township and Middletown Authority have agreed to allocate certain sewer capacity to the Township of Lower Makefield; and

WHEREAS, the Township of Lower Makefield has requested that an additional allocation be made in order to service an industrial park located in Lower Makefield Township and referred to as MAKEFIELD CENTER Industrial Development; and

WHEREAS, Middletown Township and Middletown Authority are willing to increase the allocation under the same terms and conditions of the Agreement dated the 11th day of April, 1974,

NOW, THEREFORE, intending to be legally bound hereby, the parties hereto covenant and agree as follows:

SECTION 1. The allocation referred to in Section 3 of the Agreement dated the 11th day of April, 1974, is hereby amended to read .335 MGD.

SECTION 2. Lower Makefield agrees that the aforesaid allocation is made for the specific purpose of servicing the MAKEFIELD CENTER Industrial Development located on Township Line Road South of Route 432.

SECTION 3. The connections to the Middletown Interceptor Lines shall be made at the point indicated on the attached Exhibit "A".

SECTION 4. In all other respects the agreement dated the 11th day of April, 1974, shall remain in full force and effect.


