MOTION TO CONSOLIDATE OF PENNSYLVANIA-AMERICAN WATER COMPANY

AND NOW COMES Pennsylvania-American Water Company ("PAWC"), by and through its

counsel, Cozen O'Connor, pursuant to 52 Pa. Code § 5.81, to file this Motion to Consolidate ("Motion")

the above-referenced matters. In support thereof, PAWC avers as follows:

I. Introduction and Summary

1. On October 9, 2020, PAWC filed an application pursuant to Sections 507, 1102 and 1329 of the Pennsylvania Public Utility Code ("Code"), 66 Pa. C.S. §§ 507, 1102 and 1329, to acquire the water treatment and distribution system ("Water System") currently owned by Valley Township ("Valley"). This filing was assigned Docket Number A-2020-3019859. This Application was conditionally accepted by the Commission by Secretarial Letter dated March 19, 2021 and was finally accepted by Secretarial Letter dated May 18, 2021.

2. Also on October 9, 2020, PAWC filed an application pursuant to Sections 507, 1102 and 1329 of the Code, 66 Pa. C.S. §§ 507, 1102 and 1329, to acquire the wastewater collection and conveyance system ("Wastewater System") currently owned by Valley. This filing was assigned Docket Number A-2020-3020178. This Application was conditionally accepted by the Commission by Secretarial Letter dated March 19, 2021 and was finally accepted by Secretarial Letter dated May 18, 2021.

II. Motion to Consolidate

3. PAWC respectfully requests that Administrative Law Judges Conrad A. Johnson and Emily I. DeVoe (together, the "Administrative Law Judges" or "ALJs") consolidate the proceedings at the above-referenced docket numbers because the proceedings involve common questions of law and fact.

4. In terms of common questions of fact, both applications concern PAWC's acquisition of a utility system from Valley. Valley's Water System and its Wastewater System (together, the "Systems") serve similar service territories. PAWC expects that the same parties will be involved in both proceedings, and will present the same witnesses in both proceedings. In addition, some of the witnesses' testimony will be identical because of the common questions of law in these proceedings (*e.g.*, PAWC's financial fitness to acquire the Systems). See ¶ 5, *infra*.

5. In terms of common questions of law, both cases seek Commission approval of PAWC's acquisition of utility assets from Valley pursuant to Sections 507, 1102 and 1329 of the Code. As a result, both cases will involve the following questions of law:

a. Whether PAWC is legally, technically and financially fit to own and operate the Systems presently owned by Valley;

b. Whether granting a certificate of public convenience for the proposed acquisition of the Systems is necessary or proper for the service, accommodation, convenience or safety of the public;

c. Whether the proposed acquisition of the Systems will affirmatively promote the public interest in some substantial way; and

d. Whether PAWC should be permitted to assume certain contracts with municipalities in connection with the proposed acquisitions.

6. Considering the common questions of law and fact, consolidating these proceedings would promote administrative efficiency and conserve scarce resources for the Commission and the parties.

7. Failing to consolidate these proceedings would present a risk of inconsistent decisions. It is important to Valley that it sell both Systems to one utility. Similarly, it is important to PAWC that it purchase both Systems. PAWC and Valley only filed separate applications for the Water System and the Wastewater System because the Commission will not accept one application for two different types of utility systems.

8. Before filing this Motion, counsel for PAWC shared a draft of the Motion with counsel for the Office of Consumer Advocate ("OCA"), the Bureau of Investigation and Enforcement ("I&E"), the Office of Small Business Advocate ("OSBA"), and Valley. Those attorneys authorized the undersigned counsel to represent that they have no objection to the Motion, so long as all parties, the ALJs and the Commission recognize that OCA, I&E and the OSBA are not waiving any rights to any positions any party may take in these docketed proceedings, whether consolidated or not.

III. CONCLUSION

WHEREFORE, for the foregoing reasons, Pennsylvania-American Water Company requests that the Administrative Law Judges consolidate the proceedings at Docket Nos. A-2020-3019859 and A-2020-3020178.
