PETITION TO INTERVENE

Pursuant to 52 Pa. Code §§ 5.71, 5.72 and 5.74, Valley Township ("Valley" or the "Township"), by and through its attorneys, Obermayer Rebmann Maxwell & Hippel LLP, hereby files with the Pennsylvania Public Utility Commission (the "Commission") this Petition to Intervene in the above-captioned Application of Pennsylvania-American Water Company ("PAWC") for approval of (1) the transfer, by sale, of substantially all of Valley Township's assets, properties and rights related to its water treatment and distribution system to PAWC, and (2) the rights of PAWC to begin to offer or furnish water service to the public in Valley Township, and in a portion of West Caln and East Fallowfield Townships, Chester County, Pennsylvania.

The Application directly affects the interests of Valley, which are not adequately represented by any existing party. For the reasons that follow, Valley respectfully requests that the Commission grant its Petition to Intervene, and in support thereof avers as follows:

Valley is a Township of the Second Class located in Chester County,
 Pennsylvania.

- 2. Valley's business address is 1145 West Lincoln Highway, Coatesville, PA 19320.
- 3. Valley owns, operates and maintains the Township's water system (the "Water System"), which distributes approximately 65 million gallons per year of drinking water to approximately 1,669 customers. The Water System provides water service to Valley residents, as well as 22 residents of West Caln Township and East Fallowfield Township.
- 4. Valley is interested in the above-captioned docket as a party to the agreement under which PAWC seeks approval to acquire Valley's assets, properties and rights related to its Water System.
 - 5. Valley supports the Application filed by PAWC at this docket.
- 6. 52 Pa. Code § 5.72 sets forth the eligibility requirements for a party to intervene and provides in part as follows:
 - (a) Persons. A petition to intervene may be filed by a person claiming a right to intervene or an interest of such nature that intervention is necessary or appropriate to the administration of the statute under which the proceeding is brought. The right or interest may be one of the following:
 - (1) A right conferred by statute of the United States or of the Commonwealth;
 - (2) An interest which may be directly affected and which is not adequately represented by existing participants, and as to which the petitioner may be bound by the action of the Commission in the proceeding;
 - (3) Another interest of such nature that participation of the petitioner may be in the public interest.

- 7. Valley seeks intervention in the proceeding for due cause shown for the following reasons:
 - (a) Valley is a party to the Asset Purchase Agreement (the "APA") for its Water System, which distributes approximately 65 million gallons per year of drinking water to approximately 1,669 customers. The Water System provides water service to Valley residents, as well as 22 residents of West Caln Township and East Fallowfield Township;
 - (b) As contemplated in the APA, Valley will be the recipient of the proceeds of the sale of its Water System; and
 - (c) PAWC's Application relies on Valley's consent to the sale of the Water System.
- 8. Valley has a substantial and bona fide interest in the subject matter of this docket and its interests cannot be represented or protected adequately by other existing parties to this docket.
- 9. As a party to the APA and the recipient of the proceeds from the sale of the Water System, Valley submits that its intervention is in the public interest.
- 10. Valley intends to play an active role in the Commission's decision-making process and its participation herein will not unduly prejudice any party.

WHEREFORE Valley respectfully requests that the Commission grant the instant Petition to Intervene in this proceeding.
