

Subject to Notes AA, BB, and 1 to 6 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3, and 4.

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays (any hour): 4 hours at rates named in Columns 1 and 2. Monday-Saturday (any hour): 3 hours at rates named in Columns 1, 3, and 4. For all safes and pianos, a 2 hours minimum charge applies to Column 5.

NOTE 2 - Item 325 in Tariff Freight Pa. P.U.C. No. 50 will not be offered.

NOTE 3 - Where storage-in-transit shipment is not unloaded at carrier's warehouse and shipment remains on carrier's vehicle, an overnight S.I.T. flat charge of \$250.00 per vehicle will be assessed. Waiting charge will be assessed by the carrier on the basis of a vehicle, driver and one helper at the applicable hourly rates shown above from 8:00AM following overnight S.I.T. flat charge until carrier's employees and equipment arrive at customer's location for unloading. Thereafter, carrier's hourly rates above will be assessed based on the equipment and location for unloading until completion of unloading and dismissal of equipment and labor by the shipper.

NOTE 4 - When pianos, large TVs and copy machines are part of the shipment, the following flat rate charges will be assessed in addition to the hourly rates. Spinnet - \$100.00; High-Back Upright - \$175.00; Baby Grand - \$200.00; Grand Piano - \$300.00; Large Flat Screen TVs over 64" - \$200.00; and Copy Machine - \$175.00.
