Waiting charge will be assessed by the carrier on the basis of a vehicle, driver and one helper at the applicable hourly rates shown above from 8:00AM following overnight S.I.T. flat charge until carrier's employees and equipment arrive at customer's location for unloading. Thereafter, carrier's hourly rates above will be assessed based on the equipment and location for unloading until completion of unloading and dismissal of equipment and labor by the shipper.

NOTE 4 - When pianos, large TVs and copy machines are part of the shipment, the following flat rate charges will be assessed in addition to the hourly rates. Spinet - \$100.00; High-Back Upright - \$175.00; Baby Grand - \$200.00; Grand Piano - \$300.00; Large Flat Screen TVs over 64" - \$200.00; and Copy Machine - \$175.00.
