
(a) Department of Transportation of the Commonwealth of Pennsylvania v. Consolidated Rail Corporation, Southeastern Pennsylvania Transportation Authority, Upper Merion and Plymouth Railroad Company, Boroughs of Conshohocken and West Conshohocken, Plymouth Township, Montgomery County, The Bell Telephone Company of Pennsylvania, Philadelphia Suburban Water Company, and Philadelphia Electric Company.

(b) By Commission order entered December 4, 1985, Pennsylvania Department of Transportation (PennDOT) was directed to furnish all material and do all work necessary to construct the crossing improvement that carries S.R. 3016 over and above the Schuylkill River and railroad tracks in Montgomery County. PennDOT certified to this Commission that the project was completed in accordance with our order on November 27, 1988.

(c) The Bureau of Safety and Compliance recommends that the case be closed. All matters have been completed and no further action by the Commission is necessary. It is further recommended that all parties be notified of the Commission's action by Secretarial letter.
