RULES AND REGULATIONS

ITEM 1 - Advance Reservations

Advance reservations must be made at least twenty-four (24) hours prior to the service being rendered. Reservations must be made by phone.

ITEM 2 - Hourly Rates

The business, physical and garage location of the carrier is 512 Millers Run Road, Morgan, Allegheny County, Pennsylvania 15064. The commencement of charges shall be calculated from the time the vehicle arrives at the pick up point of the client and shall conclude at the drop-off point of the client. However, an ½ hourly rate charge will be assessed for pick up or drop-off outside of the carrier's 25 mile radius.

ITEM 3 - Holiday Rates

Service provided during the following holidays will be assessed a Holiday Surcharge at the rate of 25% of the published charge: New Year's Eve, New Year's Day, Christmas Eve, Christmas Day, and Thanksgiving, Valentine's Day, Mother's Day.

ITEM 4 - Driver Gratuity

An eighteen percent (18%) gratuity will be assessed on all fares included herein.

ITEM 5 - Additional Expenses

All tolls, parking fees, and other out-of-pocket expenses will be the responsibility of the customer and added to the carrier's charges.

ITEM 6 - Promotional Fares

Upon presentation of advertising coupon or special promotional offer, carrier will offer rates at specified discount from the published tariff rates on dates authorized by the coupon or special offer. The advertised coupon or special offer will be filed with the PA PUC prior to publication or broadcast. Coupons will be published and promotional offers will be presented in one or all of the following media: Local newspaper, flyers, radio, television, and internet.

ITEM 7 - Deposits and Cancellation Policy

Carrier requires a deposit of not more than 20% of the quoted charter price. Forfeiture of deposits is within the following limitations:

Forfeiture of not more than 50% of the deposit if the charter is cancelled by the customer more than 15 but less than 30 days prior to the date the transportation was to depart, and

Forfeiture of not more than the total amount of the deposit if the cancellation occurs within 15 days prior to the date the transportation was to depart.
