NOTE 1 - When a Holiday falls on Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE 2 - Minimum total transportation charges: Sundays and Holidays (any hour): 8 hours at rates named in Columns 1 and 2.

Saturdays (any hour): 5 hours at rates named in Columns 1 and 3. Weekdays (any hour): 4 hours at rates named in Columns 1 and 4.

NOTE 3 - Travel Time Charge - When the combined distance from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal is:

- A. 15 miles or less - flat charge shall be one hour at the applicable rates.
- B. 16 miles to 25 miles - flat charge shall be one and one-half hours at the applicable rates.
- C. Over 25 miles to 40 miles inclusive) - flat charge shall be two hours at the applicable rate.
- D. For distances over 40 miles, add one-half hour for each additional 15 miles.

NOTE 4 - When a piano or safe is included in a shipment, the following additional charges will apply per each piano or safe:

Spinet Piano-\$255.00; Baby Grand Piano-\$350.00; Grand Piano - \$450.00; Safe - \$250.00
