In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles or less.

Subject to Notes AA and 1 to 7 below, the transportation charges on any shipment shall be a <u>COMBINATION</u> of the applicable <u>TRAVELING CHARGE</u> named in Column 1 plus <u>HOURLY CHARGE</u> at applicable rates named in Columns 2, 3, and 4.

Hourly rates apply only <u>from</u> time of arrival of vehicles and men at first point of origin (continuing during all loading, transportation from first point of origin to final destination, and unloading) <u>until</u> completion of unloading and dismissal of vehicles and men by shipper at destination.

Traveling charges cover traveling to first point of origin and traveling from final destination, irrespective of actual time involved in such traveling.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days, or period of days, as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any day): 8 hours at rates named in Columns 1 and 2. Saturdays (any hour) or Weekdays (4:31PM to 6:00AM): 4 hours at rates named in Columns 1 and 4.

NOTE 5 - Rates in Column 4 apply only from 4:31PM-12:00 Midnight on any day when a higher rate is shown for the following day.

NOTE 6 - Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination unless other time of arrival or dismissal is provided by agreement between the shipper and the carrier.

NOTE 7 - Service for all moves shall be secured into the carrier's schedule by the shipper making a deposit of \$500.00. This fee is non-refundable if move is cancelled or move date is postponed and carrier cannot refill the date with another move. Fee applies to shipments transported less than 40 miles and shipments transported in excess of 40 miles.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
