

Attached are updates for 400th Revised Page 2, 88th Revised Page 5, 1st Revised Page 22-C, 1st Revised Page 22-C-1, Original Page 22-C-2, and Original Page 22-C-3 for Birdish, Inc., t/a Two Men and A Truck of Princeton (PA PUC #A-8922025) in Moorestown NJ. NOTE 2 - A pre-paid deposit for equal to the Minimum Transportation Charges shown in Note 1 is required at time the move is scheduled. Cancellation Policy: 50% of deposit will be refunded if move is canceled 8-14 days prior to the move date. No refund if move is canceled 0-7 days prior to move date.

▲ NOTE 3 - When a shipment is not unloaded, at the convenience of the customer, and remains on the carrier's vehicle overnight, a charge of \$250.00 per vehicle will be assessed. Hourly rates as shown above will be assessed and applied to the next day.

▲ NOTE 4 - Carrier reserves the right to require a minimum of a 4-men crew on any move if conditions are deemed unsafe for a 2-men or 3-men crew to complete the move.

▲ Note 5 - If bed bugs are found present on any of the shipper's articles, the carrier reserves the right to dismiss the move. All fumigation costs, new uniform costs, new personal clothing costs, and new vehicle equipment costs will be billed to the customer at time of billing.

▲ NOTE 6 - Carrier reserves the right to halt all moving activities in any environments as deemed unsafe and unsanitary. Carrier reserves the right to reschedule the move once required documentation is provided.
