

In lieu of the applicable rates provided for in Tariff Freight Pa. P.U.C. No. 50 for the above carrier, the following hourly rates shall apply for shipments traveling between points in Pennsylvania and transported distances of forty (40) miles and less from origin to destination.

Subject to Notes AA and 1 to 10 below, the transportation charges on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE (Note AA) plus the HOURLY CHARGE as shown below.

NOTE 1 - Traveling charges (Note AA) are in addition to hourly rates (Columns 1, 2, 3, 4 and 5).

NOTE 2 - Hourly rates (Columns 1, 2, 3, 4 and 5) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in quarter-hour (15 minutes) periods; fractions of one-quarter hour (15 minutes) considered as one-quarter hour (15 minutes).

NOTE 4 - Minimum Transportation Charge: Weekends and Holidays (any hour): 2 hours at rates named in Columns 1, 2, 3, 4 and 5 plus applicable travel time. Weekdays (any hour): 2 hours at rates named in Columns 1, 2, 3, 4 and 5 plus applicable travel time.

NOTE 5 - When use of stairs are required to access a residence, an additional charge of \$10.00 per hour per floor will apply for stairs after the first flight. These charges apply at both origin and destination when applicable and are in addition to the hourly rates shown above.

NOTE 6 - When a spinet or console piano are included in a shipment, an additional charge of \$200.00 will be assessed plus an additional fee of \$10.00 per step if stairs are involved in moving the piano. Moving pianos is solely at the discretion of the on-site moving crew after evaluating that the piano's movement will ensure the safety of the crew, piano, and customer's home. Carrier does not move larger upright, player, baby grand or grand pianos.

NOTE 7 - In the event an elevator cannot accommodate a furniture item due to its size and the item must be carried up stairs, an additional \$100.00 charge plus \$10.00 per floor after the first flight will be assessed in addition to the hourly rates shown above. These charges apply at both origin and destination when applicable and are in addition to the hourly rates shown above.

THE FOLLOWING NOTES APPLY TO MOVES TRANSPORTED DISTANCES OF FORTY (40) MILES AND LESS AND DISTANCES IN EXCESS OF FORTY (40) MILES.

NOTE 8 - When for the convenience of the customer, a shipment is held on the truck overnight, a fee of \$400.00 per truck per night will apply.

NOTE 9 - All tolls, parking fees or other out-of-pocket expenses incurred by the moving crew while traveling to or from the jobsite or traveling from origin to final destination will be the responsibility of the customer and will be added to the carrier's final charges. These possible charges will be itemized and discussed in the moving estimate.

NOTE 10 - All jobs require a credit card on file to reserve the moving date with a \$100.00 deposit. The deposit is fully refundable if move is cancelled up to 11 full business days prior to the scheduled move date. Deposit is subject to forfeiture of 50% if the move is cancelled within 10 to 7 full business days prior to the scheduled move date. Deposit is subject to forfeiture of 100% if move is cancelled 7 full business days or less prior to the scheduled move date. Jobs booked 7 full business days or less prior to the scheduled move date require a non-refundable deposit of \$100.00.

NOTE AA (applies to moves transported forty (40) miles and less) - Travel charge to be based on the applicable transportation rates shown in Columns 1, 2, 3, 4 and 5 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest, or TruckRouter.
