**INTERIM ORDER  
SETTING RESOLUTION CONFERENCE**

On or about May 6, 2021, and May 10, 2021, Walter L. Clark ("Complainant") filed Complaints against Pennsylvania-American Water Company ("Respondent"), at the above-captioned docket numbers. On or about June 1, 2021, and June 7, 2021, respectively, Respondent filed an Answer and New Matter to the Complaints. On or about June 7, 2021, Complainant filed a Reply to Respondent's New Matter.

Based upon a review of the information contained in this material, I direct the parties to attempt to resolve this matter themselves. Respondent shall contact Complainant to set a mutually convenient date and time for Respondent and Complainant to hold a conference about resolving the case. The conference must take place no later than July 9, 2021, unless this is not possible.

**Within ten (10) days following the conference, Respondent shall file a short report with Mediator Cynthia Lehman ("Mediator"), setting forth:**

- (a) The date of the conference;
- (b) Who participated for each party;
- (c) A statement whether a full resolution, including withdrawal of Complaints, was achieved, and, if not, whether the parties consent to have this case set for mediation by the mediation staff of the Commission; and
