<b>Classification</b>	<b>Criteria for Inclusion in Classification: Usage Level, Etc.</b>
<b>1. Small Non-Residential</b>	Secondary service with monthly usage of 1,500 kWh or less
<b>2. Medium Non-Residential</b>	Secondary service with monthly usage greater than 1,500 kWh and less than 100 kW
<b>3. Large Non-Residential</b>	Secondary, Primary and Transmission service with monthly demand greater than 100 kW
