
Dear Ms. Roth,

Please find a copy of the Power of Attorney for Millennium Moving LLC (PA PUC Certificate #A-8923968 – A-2021-3024868) in Oreland PA attached to this email. This is a “transfer” of operating authority. The “old” mover was Millennium Moving Co., Inc. (PA PUC #A-00115679) in Collegeville PA. The “new” operating authority is for transporting household goods, in use, “between points in Pennsylvania.” Millennium Moving LLC is a member of Tristate Household Goods Tariff Conference, Inc. subscribing to tariffs, Tristate 50-T (local moves), Tristate 51-W (intrastate moves) and Tristate 54 (exceptions).


