	<p style="text-align: center;"><u>OPERATING AUTHORITY</u></p> <p style="text-align: center;"><u>Certificate No. A-00121828</u></p> <p>To transport, as a common carrier, by motor vehicle, persons, in limousine service, between points in Pennsylvania; excluding service that is under the jurisdiction of the Philadelphia Parking Authority.</p>
ITEM	RULES AND REGULATIONS
10	<p style="text-align: center;"><u>ADVANCE RESERVATIONS</u></p> <p>Advance Reservations must be made prior to when service is to be rendered.</p>
20	<p style="text-align: center;"><u>DRIVER GRATUITY</u></p> <p>A twenty (20%) percent Driver Gratuity will be assessed in addition to all other published rates and charges.</p>
30	<p style="text-align: center;"><u>PAYMENT OF OUT-OF-POCKET EXPENSES</u></p> <p>All tolls, parking fees and other out-of-pocket expenses shall be the responsibility of the customer and will be added onto carrier's charges.</p>

40	<p style="text-align: center;"><u>HOURLY RATES</u></p> <p>Hourly rates will take effect from the time the vehicle leaves the carrier's facility until the time the vehicle returns to the carriers' facility.</p>
50	<p style="text-align: center;"><u>PROMOTIONAL FARES</u></p> <p>Upon presentation of advertising coupons or promotional offers, the carrier will offer rates at specified discounts from the published Tariff rates on dates authorized by the coupon or promotional offer. The advertised coupon or promotional offer will be filed with the Public Utility Commission prior to publication and/or broadcast. Coupons will be published, and promotional offers will be broadcast in one or all of the following manners: local newspaper, fliers, other types of printed media, and all forms of radio and television advertising, including the internet.</p>
60	<p style="text-align: center;"><u>HOLIDAYS</u></p> <p>Customers will be charged an additional twenty (20%) percent of the applicable rate for services provided on the following Holidays: New Years Eve, New Years Day, Easter, Memorial Day, Fourth of July, Labor Day, Thanksgiving Day, Christmas Eve and Christmas Day.</p>
70	<p style="text-align: center;"><u>DEPOSITS</u></p> <p>All reservations require a deposit of twenty (20%) percent of the quoted price for service based on the Customer's estimated use of the limousine. One-half of the deposit shall be forfeited if the reservation is cancelled by the Customer more than 15 but less than 30 days prior to the date the service was to be provided. The full deposit shall be forfeited if the reservation is cancelled within 15 days prior to the date the service was to be provided.</p>
