Dear Ms. Amodeo,

I am the prosecuting attorney for the Pennsylvania Public Utility Commission's (PUC) Bureau of Investigation and Enforcement (I&E), and I am writing you in efforts to satisfy the Complaint against J&B Limousine Service & Auto Leasing Inc. t/a Elegant Arrivals LLC., ("Company") at the above docket number. Specifically, I&E will offer the Company an opportunity to satisfy the Complaint if it 1) causes its insurer to file appropriate evidence of Form E liability insurance(s) with the PUC or notifies I&E by letter that it has applied to abandon its operating authority **and** 2) pays a reduced civil penalty amount of \$250 in order to satisfy the Complaint. The civil penalty must be paid by **certified check or money order**, made payable to "**Commonwealth of Pennsylvania**" with the docket number of this proceeding listed, and mailed to *me* at the address listed above within **twenty (20) days** of the service of this letter.

Should the Company elect not to cause its insurer to file evidence of Form E liability insurance(s) or notify I&E that it has applied abandon its authority, and elect not to pay the reduced civil penalty of \$250 as satisfaction of this Complaint, please be advised the Complaint will be assigned to an Administrative Law Judge and the matter will move forward to an evidentiary hearing wherein the larger, original fine will be sought, the Company's operating authority may be cancelled, and further remedies may be imposed as deemed appropriate by the Commission. Finally, pursuant to 52 Pa. Code §§ 1.21 and 1.22, should this matter proceed to a hearing, the Company will be required to be represented by an attorney at the hearing, which will require incurring those additional legal costs as well.
