Please be advised that PPL Electric Utilities Corporation (“PPL Electric”) will not be filing Exceptions to the Recommended Decision (“RD”) in the above-referenced proceeding. In lieu of filing Exceptions, PPL Electric respectfully requests that the sentence on page six of the RD that reads “the Commission reversed the Commission” be modified to state that “the Commonwealth Court reversed the Commission.” In addition, PPL Electric notes that, while the RD recommends approval of the Joint Petition for Settlement, the RD does not contain an ordering paragraph granting a certificate of public convenience for the Proposed Restructuring pursuant to 66 Pa. 
