Proposed Modification of Intermunicipal Agreements (Except Springettsbury Township)¹

Modify all Articles of Agreement between the City of York and the municipalities, as amended, (each, "Agreement") as follows:

1. Repeal Section 8 in its entirety and replace it with the following:

Municipality shall pay Pennsylvania-American Water Company ("PAWC"), for wastewater collection and treatment services rendered, the default bulk rates set forth in PAWC's Tariff Supplement No. __, at Page __ as approved by the Pennsylvania Public Utility Commission ("PUC") on _____, 202_ at Docket No. A-2021-3024681. Municipality agrees to pay PAWC based on the total number of gallons (or EDUs where applicable).

Municipality agrees that it shall annually provide in its Budget for obtaining the necessary funds to meet its obligations under this Agreement and to that end shall by proper ordinances or resolutions make provision for the imposition of sewer rentals, the levying of special taxes or any other lawful method or methods to provide for obtaining sufficient revenues, in such manner as to assure that Municipality shall obtain or collect during each year, the amounts which may be due or may become due under the terms of this Agreement.

2. Repeal Section 8-A in its entirety.
3. Repeal Section 10 in its entirety and replace it with the following:

Notwithstanding any provisions herein to the contrary, the treatment capacity allocated to Municipality shall be the capacity allocated to Municipality at the time of assignment of this Agreement by City to PAWC. Renegotiations of allocated capacity shall be done in conformity with this Agreement but only to the extent consistent with the tariffed Rules and Regulations of PAWC as approved by the PUC.

4. These modifications will take effect upon assignment of this Agreement by City to PAWC.

¹ These proposed modifications are for the intermunicipal agreements for bulk treatment and collection service for the following municipalities: Manchester Township; North York Borough; Spring Garden Township; West Manchester Township; West York Borough (which has been assigned to The York Water Company); and, York Township.

Proposed Modification of Intermunicipal Agreement with Springettsbury Township

Modify the Articles of Agreement between the City of York and Springettsbury Township (“Agreement”) as follows:

1. Repeal Sections 5.01, 5.02, 6.01, 6.02, 6.03, 6.04, 6.05, 8.03, and 8.04 in their entireties and replace them with the following:

Municipality shall pay Pennsylvania-American Water Company (“PAWC”), for wastewater collection and treatment services rendered, the default bulk rates set forth in PAWC’s Tariff Supplement No. __, at Page __ as approved by the Pennsylvania Public Utility Commission (“PUC”) on _____, 202_ at Docket No. A-2021-3024681.

2. This modifications will take effect upon assignment of this Agreement by City to PAWC.
