On behalf of Rasier-PA LLC ("Rasier"), enclosed is a check for five hundred dollars (\$500.00). This is the fine amount requested by the Bureau of Investigation and Enforcement to terminate further proceedings in connection with the above-captioned Complaint ("Complaint"). The Complaint alleges that Rasier is subject to the Pennsylvania Public Utility Commission's jurisdiction pursuant to a license issued to Rasier at Docket No. A-2016-2580821 on January 26, 2017, authorizing the transportation of persons for compensation in Transportation Network Company ("TNC") service. In addition, the Complaint alleges that Rasier is in violation of 52 Pa. Code § 29.402(1) governing the inspection standards of common carriers or contract carriers and 67 Pa. Code § 175.66(h) governing vehicle lighting.

Without admitting liability under these specific provisions, Rasier does not contest payment of the requested fine and is forwarding the requested penalty amount in order to resolve and close this Complaint.
