Dear Mr. Errigo:

On August 26, 2020, the Public Utility Commission (Commission) accepted GREENCROWN Energy, LLC's (GREENCROWN) application for an Electric Generation Supplier license. By Commission Order entered on November 19, 2020, GREENCROWN's application was denied. On November 26, 2020, GREENCROWN filed a Petition for Reconsideration, Rescission and Reinstatement. On December 17, 2020, the Petition for Reconsideration, Rescission and Reinstatement was granted, pending further review of, and consideration on, the merits. On May 6, 2021, the Commission issued an Opinion and Order, granting the Petition for Reconsideration, Rescission and Reinstatement, filed by GREENCROWN and referred the application to the Bureau of Technical Utility Services for further action as deemed necessary. The application of GREENCROWN, as submitted on August 26, 2020, was incomplete. In order for us to complete our analysis of your application, the Energy Industry Group requires answers to the attached questions.

Failure to respond may result in the application being denied. As well, if GREENCROWN has decided to withdraw its application, please reply notifying the Commission of such a decision.


