Dear Secretary Chiavetta,

In accordance with the Pennsylvania Public Utility Commission’s March 18, 2021 Order in the above-referenced docket, AT&T Corp. and Teleport Communications America, LLC (collectively, “AT&T”) provide the following information covering the second quarter of 2021:

- a. Total number of residential and non-residential accounts at risk of termination at the end of the quarter and for the same month of 2019 and 2020.
- b. Total aggregate dollars of arrears at the end of the quarter and for the same month in 2019 and 2020 (both total and by vintage, i.e., 30-60 days, 60-90 days, 90+days).
- c. The number of accounts disconnected for non-payment with dollar amounts owed.
