Request for Extension of Time to September 17, 2021 for National Fuel to File Response/Provide Supplemental Information Requested in the Commission's July 15, 2021 Order Directing Supplemental Information and Establishing Comment Period ("Order")

For the reasons identified below, National Fuel respectfully requests that the Pennsylvania Public Utility Commission (the "Commission") extend the deadline for National Fuel to file its response/provide the supplemental information (the "Supplemental Information") identified in the Order to **September 17, 2021** ("Extension Request").

After thorough internal review, National Fuel makes this Extension Request so as to enable it to provide the Commission (and other stakeholders) with robust, responsive and accurate Supplemental Information. In this regard, National Fuel makes this Extension Request after having already: (1) commenced its review of the Order with internal stakeholders; and (2) beginning to compile the Supplemental Information requested in the Order. As a result, in reviewing the Supplemental Information requested in the Order with pertinent internal stakeholders (including, among others, those in Consumer Business, Information Technology, and Rates and Regulatory Affairs), National Fuel believes it will be unable to provide all of the Supplemental Information until the extended response deadline requested above (*i.e.*, September 17, 2021).

Beyond providing National Fuel with the opportunity to provide robust, responsive, and accurate supplemental information, National Fuel also believes that this Extension Request will provide other interested stakeholders with additional time to review National Fuel's Plan and the Commission's comments on same identified in the Order.
